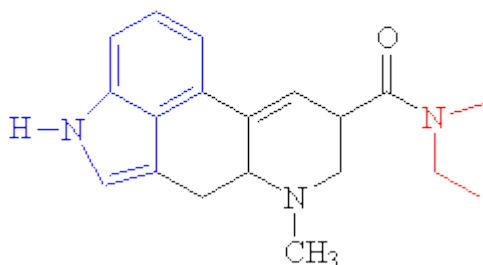

**LSD acid:-**

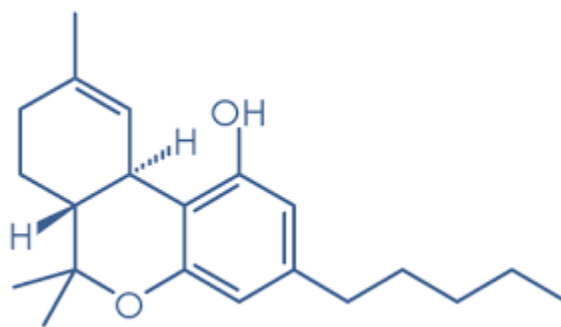

**Marijuana:-**

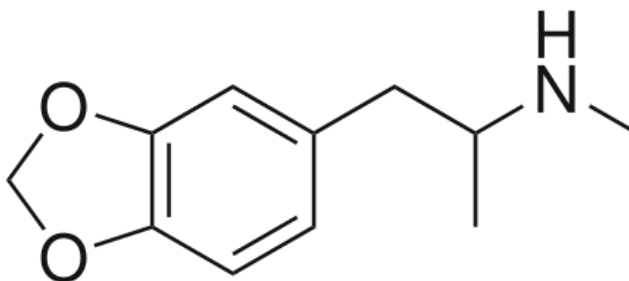

### MDMA (Ecstasy):-

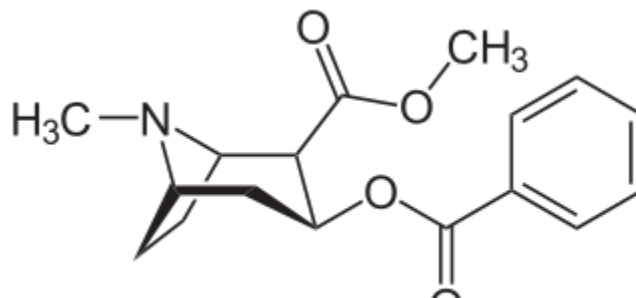

### Cocaine:-

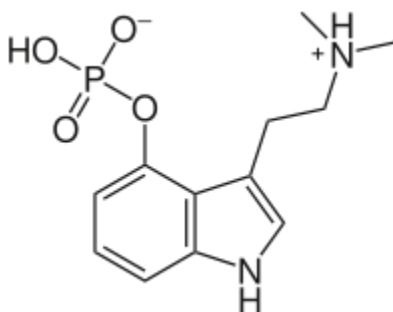

### **Psilocybin (Magic mushrooms)**

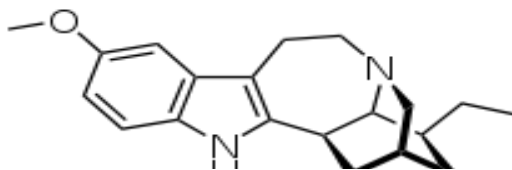

### **Ibogaine:-**

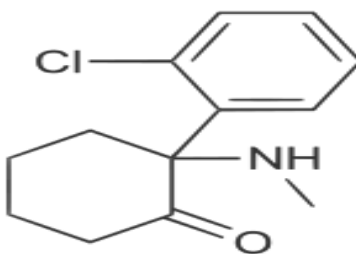

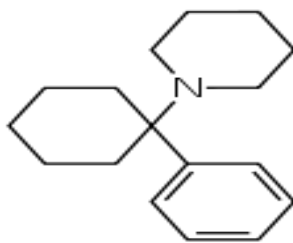
### **Ketamine:-**

## **DRUG POLICY IN INDIA:**

As we all know that there are licit and illicit drugs. Government have amended the act called NDPS act (Narcotic Drugs and Psychotropic Substances act) to control the practice of illicit drugs .

### **NDPS Act 1985:-**

India is a party to the 3 United countries drug gatherings – the 1961 single conference on Narcotic pills (1961 conference), the 1971 conference on Psychotropic substances (1971 convention) and the 1988 convention in opposition to Illicit site visitors in Narcotic capsules and Psychotropic substances (1988 convention). Domestic law to give effect to those treaties changed into delivered only in the 1980s at the same time as the ‘grace length’ for abolishing non-scientific use of cannabis and opium beneath the 1961 conference expired. Exercise its powers to make rules and regulation for the united states of america for enforcing “any treaty, settlement or conference or decision made at worldwide convention”, the Indian Parliament handed the Narcotic drugs and Psychotropic substances Act, 1985 (NDPS Act) rapidly, without a lot debate. The NDPS Act came into force on 14 November 1985, replacing the Opium Acts and the damaging capsules Act. The 1940 drug and Cosmetics Act, 1940, but, keeps to use.<sup>17</sup> The authentic document states that the NDPS Act became enacted on the way to provide good enough penalties for drug trafficking, improve enforcement powers, implement international conventions to which India turned into a party, and put in force controls over psychotropic substances. The Act became amended in 1989, 2001 and extra lately in 2014. The NDPS Act prohibits cultivation, production, possession, sale, purchase, exchange, import, export, use and consumption of narcotic pills and psychotropic materials except for medical and clinical functions in accordance with the law. Training to devote certain offences is punishable as it is attempted. Accessory crimes of aiding and abetting and crook conspiracy entice the equal punishment as the predominant offence. The Act covers three vast lessons of substances: 1) narcotic drugs, that is, those included beneath the 1961 conference; 2) psychotropic substances or the ones blanketed beneath the 1971 convention in addition to different psychoactive substances including ketamine which are not but categorized below 3 international conventions; and 3) “controlled substances” that are used to manufacture narcotic drugs or

psychotropic substances, for example precursor chemicals such as acetic anhydride, ephedrine and pseudoephedrine.

#### **NDPS Amendment 1989:-**

In 1989, the NDPS Act underwent the primary set of amendments, after a cabinet Sub- Committee for preventing drug trafficking and abuse endorsed that the law should be made extra severe. The ‘tough on drugs’ rhetoric led to the introduction of very harsh provisions such as mandatory minimal sentences of 10 years’ imprisonment, regulations on bail, bar on suspension and commutation of sentences, forfeiture of property, trial by way of unique courts and mandatory demise sentence for positive repeat offenders. The changes, which came in less than 4 years after the regulation was first of all exceeded, appear to were prompted through international, regional and domestic tendencies – namely, the signing of the 1988 conference; deliberations on the South Asian association for nearby Cooperation (SAARC) at the growing risk of drug trafficking, growing political dissent and ‘terrorist’ hobby in northern states and the belief that terrorism is fuelled by means of drug trafficking.

#### **NDPS Amendment 2001:-**

Grievance of this harsh and disproportionate sentencing shape created a momentum for reform. In 1998, the NDPS (modification) bill, was brought in Parliament and sooner or later examined by means of the Parliamentary status Committee on Finance. The amendments have been ultimately followed in 2001, to grade punishment on the idea of the amount of drugs involved – that is, “small”, “business” or “intermediate”. Thresholds were unique via the central authorities via a notification dated 19 October 2001.

#### **NDPS Amendment 2014:-**

In early 2014, the NDPS Act became amended for the third time and the new provisions got here into pressure on 1 May also 2014. The primary functions include:

- Creation of a brand new class of “crucial narcotic capsules”, which the imperative government can specify and alter uniformly at some stage in the country.
- Widening the objective of the regulation from containing illicit use to additionally promoting the medical and clinical use of narcotic drugs and psychotropic substances in keeping with the principle of ‘balance’ among manipulate and availability of narcotic drugs that underpins the worldwide drug manipulate treaties



- consisting of the phrases “management” of drug dependence and “popularity and approval” of remedy centers, accordingly allowing for the status of legally binding remedy requirements and proof-based totally clinical interventions.
- Making the loss of life penalty discretionary for a subsequent offence regarding a positive quantity of medicine below section 31A. The courtroom can have the alternative to impose imprisonment for 30 years under section 31
- Stronger punishment for small amount offences from a most of six months to 12 months imprisonment
- Allowing non-public zone involvement within the processing of opium and focused poppy straw
- Elevating the rank of officers legal to behavior seek and arrest license holders for alleged NDPS violations.
- More intricate provisions for forfeiture of assets of individuals arraigned on prices of drug trafficking.
